<b>What is the overall deductible?</b>	Calendar year aggregate deductible. In-network: \$2,000 Individual / \$4,000 Family. Out-of-network: \$4,000 Individual / \$8,000 Family.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. <b>Are there services covered before you meet your deductible?</b>	Yes.
