**GROUP SHORT TERM DISABILITY INCOME INSURANCE**

**Short Term Disability**

Disability income insurance can provide a portion of the income you would lose if you became disabled and could not work. This would help to pay your everyday living expenses and it may assist you in maintaining the standard of living you and your family now enjoy.

**Definition of Disability**

Disabled/Disability means our determination that your sickness or injury:

- Prevents you from performing with reasonable continuity the material and substantial duties of your regular occupation and a reasonable employment option offered to you by the employer; and
- As a result, the income you are able to earn is less than or equal to 80% of your pre-disability earnings.

Material and substantial duties are the duties that:

- Are normally required for the performance of the occupation;

**AND**

- Cannot be reasonable omitted or changed.

**Eligibility**

All Eligible Active Employees of Participating Employers enrolled in TPMA whose Employer elects Plan 1 working a minimum of 20 hours per week.

**Benefits**

If you become disabled and have short term disability coverage, benefits begin after 7 days of sickness or at the occurrence of an accident. Symetra Life Insurance Company will pay your benefit to you while you are disabled under the terms of the policy. The short term disability income weekly benefit will be a flat amount of \$100 per week. The minimum weekly benefit is \$25. The maximum payment duration is 26 weeks.

**Standard Provisions**

- Maternity is covered as any other condition
- 14 day recurrent disability/temporary recovery
- Cost of Living Freeze
